Dear Sir.

1. I have been appointed as the Scrutinizer by M/s. Neil Industries Limited ("the Company", herein after), pursuant to section 108 of the Companies Act, 2013, read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended by the Companies (Management and Administration) Amendment Rules, 2015 and pursuant to the applicable provisions of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, to carry out the scrutiny of the Remote E-Voting as well as Electronic Voting at the 42nd Annual General Meeting (AGM) of the Company held on September 27, 2025 at 11:00 A.M. through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM") as permitted by the Ministry of Corporate Affairs (MCA) vide its circular dated May 5, 2020 read together with circulars dated April 8, 2020, April 13, 2020, January 13, 2021 Circular No 02/2021 dated December 14, 2021, Circular No 02/2022 dated May 05, 2022 and Circular No 10/2022 dated December 28, 2022 and all other relevant circulars issued from time to time.

2. Further pursuant to the MCA and SEBI Circulars, the Notice of AGM along with the Annual Report for FY 2024-25 was sent in electronic form only to those Members whose e-mail addresses are registered with the Company/Depositories. Since this AGM was held pursuant to the MCA Circulars through VC or OAVM, physical attendance of Members had been dispensed with, accordingly, in terms of the above-mentioned MCA and SEBI Circulars, the facility for appointment of proxies by the Members were also dispensed with. Members attended the meeting through VC or OAVM had been counted for the purpose of reckoning the quorum under Section 103 of the Companies Act, 2013.

- 3. My responsibility as Scrutinizer for e-voting process i.e., remote e-voting and Electronic Voting is restricted to making a Consolidated Scrutinizer's Report of the votes cast "in favor" or "against" the resolutions contained in the Notice, based on the reports generated from the e-voting system provided by M/s. National Securities Depository Limited ("NSDL", herein after) authorized under the Rules and engaged by the Company to provide e-voting facility and attended papers/documents furnished to me electronically by the company and/or NSDL for my verification.
- **4.** The Equity Shareholders of the Company as on the "cut-off" date, as set out in the Notice, i.e., 19th September, 2025 were entitled to vote on the resolutions as set out in the Notice calling the AGM and their voting rights were in the proportion to their share in the paid-up equity share capital of the Company as on the cut-off date.
- **5**. The remote e-voting period remained open from Wednesday the 24th day of September 2025 9:00 A.M. till Friday the 26th day of September 2025 5.00 P.M. The votes cast were unblocked on 27th September, 2025 around 12.10 P.M after the conclusion of the AGM.

Thereafter, the details containing, inter alia, the list of Equity Shareholders who voted "in favor" or "against" on each of the resolutions that was put to vote, were generated from the e-voting website of NSDL, i.e., www.evoting.nsdl.com. Based on the report generated by NSDL and relied upon by me, data regarding the remote e-voting was scrutinized on test check basis.

After the time fixed for closing of the e-voting by the Chairman, the electronic system recording the e-voting (e-votes) was locked by NSDL.

The e-votes cast were unblocked on 27th September 2025 after the conclusion of the AGM.
